# SPEAKER & FACILITATOR PROFILES



**Dr Janine Hicks** is a Senior Lecturer at the School of Law, where she serves as convenor for the Navi Pillay Research Interest Group and Chairperson of UKZN's Gender-based Violence Committee. She is the Coordinator for Street Law and lectures on Master of Laws (LLM) offerings on Constitutional Litigation and Employment Discrimination Legislation. Hicks holds a PhD and an LL B from the University of KwaZulu-Natal and a Master of Arts (MA) in Development Studies from the University of Sussex, United Kingdom. Hicks is the Project Leader for the South African Law Reform Commission's Project 143 on Maternity and Paternity Benefits for Self-Employed Workers and a Council member of the state's Human Resource Development Council. Her research interests are in transformative constitutionalism, access to justice, and equality jurisprudence. Before joining the School of Law in 2017, Hicks worked from the early 1990s in the non-governmental organisation human rights sector, thereafter serving two terms as Commissioner with the Commission for Gender Equality, one of South Africa's constitutional institutions supporting democracy.

Hon. Maria Stylianou-Lottides, a prominent figure from Cyprus, currently holds the position of Commissioner for Administration and the Protection of Human Rights (Ombudsman). She was initially appointed in 2017 and reappointed in 2023. She also serves on the Management Board of FRA (European Union Agency for Fundamental Rights) since July 2020. She is a member of the Board of Directors of the AOM (Association of Mediterranean Ombudsmen). She earned her Law Degree from the National and Kapodistrian University of Athens in 1997. Subsequently, she succeeded in the PanCypriot Bar Association examination, establishing herself as an active member of the Cyprus Bar Association. In 2009, she obtained an LLM in European Union Law from Leicester University, focusing on "Protection of Human Rights in the European Union." Maria has held various positions, including Advocate/Barrister, Lawyer/Counselor at the Attorney General's Office, and Commissioner for Administration and Human Rights Protection. Her leadership is evident in her oversight of the Equality Body, Cyprus NHRI, and important mechanisms responsible for monitoring human rights and UN Conventions. She has also been a driving force behind significant initiatives such as the National Mechanism against Torture and Independent Mechanism for Forced Returns. Her memberships in organizations like IOI Europe, ENO, EQUINET, and ENNHRI showcase her global commitment to advancing human rights.





Hon. Grace Tikambenji Malera was appointed as Ombudsman of Malawi effective 1<sup>ST</sup> September 2021. She is a Lawyer and Human Rights Expert, with 20 years of work experience working with both state and non-state actors. She has worked across the governance sector in Malawi, on a broad range of thematic areas including: human rights broadly; gender and women's rights, children's rights and access to justice. She holds a Bachelor of Law Degree (LLB Honours), obtained from the University of Malawi, Chancellor College in 2002, and graduated from the University of the Free State, Republic of South Africa with a Masters in Law Degree (LLM) in 2007. She was called to the Malawi Bar in 2002, to practice law in both the Supreme Court and High Court of Malawi, and courts subordinate thereto. She has vast experience working with regional and international human rights mechanisms at the African Commission and United Nations levels respectively. She served as a member of the Special Law Commission on the Review of Electoral Laws (2016/2017), as well as a member of the Special Law Commission on the Development of the Trafficking in Persons Legislation. She is an exceptional human rights and gender advocate. She is an architect of some NGOs working in governance as well as in the advancement of women's rights in Malawi and serves in a number of Boards of human rights NGOs in Malawi. She is passionate about using the law as a tool for social change and attainment of social justice and gender equality and social inclusion. In 2019 Grace was the Moderator of Malawi Presidential Debate ahead of the 2019 Malawi Tripartite Elections.

Hon. Nichole Tirant-Ghérardi, the fourth Ombudsman of Seychelles, began her sevenyear term on March 30, 2017. A Seychellois Barrister and Attorney-at-Law, she started her career in the Seychelles Civil Service in 1978, initially working in nature conservation, fisheries, and agriculture at the Ministry of Agriculture and Fisheries. In 1983, she shifted back to law, serving as a state counsel in the Office of the Attorney General, and later entered private practice in 1986, becoming one of the pioneering women in the field. After a period in France, she returned to Seychelles in 1994, resuming legal practice and later taking on the role of Secretary General of the Seychelles Chamber of Commerce and Industry (SCCI). From 2004 to 2008, she played a significant part in negotiating post-Cotonou Economic Partnership Agreements between the European Union and the Eastern and Southern African region. In 2010, she co-founded "Today in Seychelles," the second privately-owned daily newspaper in the country, where she worked as the Managing Editor. As the Ombudsman, she adopts a proactive approach, carefully analyzing complaints to drive improvements in public sector service delivery and administration. Born in Kenya and raised in Seychelles, Nichole holds a Bachelor of Law Degree (LLB) from the University of Liverpool and has been a Gray's Inn of Court member since June 1983. She also pursued French Civil Law at the University of Toulon, France.
