THE THIRD “BEST OF” SEMINAR

This seminar is the third in a series. It is designed for anti-corruption experts, business and government executives, leaders of civil society organizations and academics who are interested in improving the design management, and sustainability of anti-corruption efforts.

A UNIQUE OPPORTUNITY

In these exciting two days, participants will be given guidance on how companies, countries, cities, and other entities can launch and sustain preventive and curative measures against corruption.

Professor Klitgaard will lead participants through interactive case studies of effective anti-corruption efforts. The examples include cities, ministries, and countries at various stages of development. The roles of business and civil society organizations are highlighted.

Participants will also appraise the state of the art in measuring governance. They will examine the latest evidence on the importance of good governance for fighting poverty, enhancing investment, and improving public confidence.

In the evening, all participants are invited to a networking dinner with Professor Klitgaard at a traditional Viennese restaurant.

BIOGRAPHY

Robert Klitgaard is a University Professor at Claremont Graduate University, where he served as President from 2005 to 2009. Formerly Dean of the Pardee RAND Graduate School and a professor at Yale and Harvard, Robert Klitgaard advises governments around the world on institutional reform. He has been called “the world’s leading expert on corruption” (The Christian Science Monitor).



PUBLICATIONS

Among his books are *Tropical Gangsters*, which was included in The New York Times’ Books of the Century, and *Choosing Elites*, which appears in The Harvard Guide to Influential Books.

His books on corruption are used throughout the world (*Corrupt Cities* has been translated into 18 languages and *Controlling Corruption* into eight).
