SPEAKER & FACILITATOR PROFILES



Hon. Lady Justice Tujilane Rose Chizumila is a national of Malawi and was elected Judge of the African Court on Human and Peoples' Rights in January 2017 during the 28th Assembly of Heads of State and Government of the African Union, for a six-year term. Justice Chizumila has a Master's in International Law and has held several positions in the judicial, Legal, Academic, Diplomatic, administrative, governance and corporate fields in Malawi, including Judge of the High Court of Malawi, State Advocate and Legal Aid Advocate with the Ministry of Justice, Secretary of the Law Society of Malawi, first Female Ombudsman, Malawi High Commissioner to Zimbabwe and Proprietor and Founder of Chizumila and Company. She has a number of publications to her credit, including 'A widow's perspective – a personal experience'', a publication which led to the enactment of a law in Parliament, making property grabbing an offence in Malawi. Justice Chizumila speaks English and Swahili.

Hon. Fatimata SANOU/TOURE was promoted to the position of Mediator of Faso on 26 November 2021. She is committed to consolidating the institution's achievements and strengthening its visibility through its institutional roots and influence at sub-regional, regional and international levels. In this capacity, she holds the post of Secretary General of the Association of Mediators of the UEMOA region (AMP/UEMOA). She is a Magistrate committed to the defence of citizens' rights and the promotion of sexual and reproductive health and family planning. She has successively held the positions of senior investigating judge with the rank of vice-president of the High Court of Ouagadougou, President of the High Court of Ouagadougou. With a specialisation in Law of Development at the International Organisation of Development Law (OIDD) in Italy, she has become known over the years through her active representation in organisations for the defence and promotion of Human Rights. the Association of Women Lawyers of Burkina Faso and then Vice-President of the Foundation for the Study and Promotion of Human Rights in Africa (FEPDHA)



Ms. Domonie Pierre has an LL.B., a Master's degree in Macro Human Resource Planning, and is a member of the Law Society of Ontario. Since joining Ombudsman Ontario in 2006, she has worked as an Early Resolutions Officer, an investigator, and a member of the Special Ombudsman Response Team (SORT) team, prior to becoming the Director in 2020. Domonie has led a number of high-profile systemic investigations at Ombudsman Ontario, including Oversight 911, an investigation into the government's oversight of complaints about emergency health services; The Code, an investigation into the use of excessive force against inmates and the "code of silence" among correctional staff; and Caught in the Act, an investigation into the expansion of police powers during the 2010 G20 summit in Toronto.

Mrs. Anne Twinomugisha Muhairwe is the Deputy Inspector General of Government. She is a Christian Lawyer with a strong belief in societal transformation and development. She has put her academic exposure into practice for the last 15 years in the Ministry of Defence and Veteran Affairs under different portfolios; first as a Prosecutor in the General Court Martial and rose through the ranks to the level of Principal Legal Officer. She is credited for the establishment of the Veterans Legal Aid Clinic and creating a supportive mechanism for women's involvement in peace building, amongst her many achievements. She is the current President (and previously a board member) of the Uganda Christian Lawyers Fraternity. She is also a member of Uganda Law Society, the East African Law Society and Uganda Federation of Women Lawyers. She was also recently recognised as one of the most influential lawyers.
