#### **Dr Janine Hicks**

is a Senior Lecturer at the School of Law where she serves as convenor for the Navi Pillay Research Interest Group, and Chairperson of UKZN's Gender-based Violence Committee.

Hicks holds a PhD and an LL B from the University of KwaZulu-Natal, and a Master of Arts (MA) in Development Studies from the University of Sussex, United Kingdom. Her research interests are in transformative constitutionalism, access to justice and equality jurisprudence.

Before joining the School of Law in 2017, Hicks worked from the early 1990s in the non-governmental organisation human rights sector, thereafter serving two terms as Commissioner with the Commission for Gender Equality, one of South Africa's constitutional institutions supporting democracy.



#### Hon. Nashieli Ramirez Hernandez

is a seasoned human rights advocate with over 40 years of experience in Mexico. She currently serves as the President of the International Ombudsman Institute (IOI) since May 2024 and has been the President of the Human Rights Commission of Mexico City since 2017, re-elected for a second term until 2025. She holds advanced qualifications in educational research, teaching practice, and planning, as well as specialized training in local government, security, justice, and child labor policies.

Her leadership in the Ombudsperson System includes roles such as Third Vice-President of the Global Alliance of Local Ombudspersons (AGOL), Coordinator of the Network on Children and Adolescents of the Ibero-American Federation of Ombudsman (FIO), and former President of the Mexican Federation of Public Human Rights Bodies (FMOPDH). In the international arena, she has been involved with the Organisation of Ibero-American States for Education, Science and Culture (OEI) and founded key organizations like Ririki Intervención Social, S.C., and the Alliance for the Rights of Children and Adolescents. Her academic contributions include over 50 research projects and publications on social issues, including works on human rights, migration, and intergenerational democracy.



#### Ms. Lwandisa Zaula.

is a dedicated professional with a dynamic academic background, holding a Bachelor of Law (LL.B), a Bachelor of Social Science and an Honors degree in Anthropology from the University of Fort Hare. With a passion for justice and social equity, she has combined the principles of legal studies and social science to address complex societal issues effectively. In her role as a Portfolio Coordinator at DMC Ms Zaula showcased exceptional project management and organizational skills. She oversaw various clients' portfolios, coordinating team efforts to ensure that projects were delivered on time and met clients' expectations.

#### Hon. Caroline Chuma Zulu Sokoni,

the current Public Protector of Zambia and the Secretary General of AOMA, has served in the office of the Country's National Ombudsman for fifteen (15) years. She began her professional career in 1989 as a State Advocate under the then Ministry of Legal Affairs (now known as Ministry of Justice). She has a Masters of Law in Criminology from Queen Mary and Westfield College, University of London in the United Kingdom and served under the Ministry of Justice for fifteen years.

She was appointed as Acting Director of Public Prosecutions for the Republic of Zambia in February 2004 and was also appointed as the Task Team leader for the Legal component of the Water Resources Management Project, a policy formulation body tasked to spearhead the reform of the Water Resources Management process in Zambia. She presided over the Town and Country Planning Tribunal as the Vice Chairperson between 2003 and 2005. In November 2004, she was appointed as the Investigator General for Zambia's National Ombudsman Office. At the time of her appointment the Office was known as the Commission for Investigations.
